



What We've Heard: Immediate Needs Shared at the November Task Force Meeting and Other Recent Discussions

TOPIC	Description		
Staffing Shortages at all Community Providers	Agencies understaffed, overwhelmed, and without enough resources to meet needs.		
Gaps in Treatment	 Difficulty connecting people to appropriate level of care Treatment needs to be equitable and culturally appropriate Disconnect between organizations and services Need more providers Need higher Medicaid reimbursement rates 		
Affordable Housing	 Huge increase in unhoused individuals No shelter beds Individuals who qualify for rental assistance can't find available rooms/apartment Need to adopt housing first policies 		
Transportation Outside Providence, Pawtucket	Racial Equity Work Group to hold focus groups to help identify bias and discrimination and barriers to treatment.		
Race Equity Strategic Planning	Needing to ensure that the entire Task Force takes on race equity – not just the Racial Equity Work Group.		
Access to Legal Documents	Individuals struggle to obtain licenses, birth certificates, social security due to fees/application process.		
Overdoses in Private Settings			
Structural/Systemic Problems	Racism, poverty, discrimination/stigma - from community providers.		

Highlights: Work Group Efforts to Address Evidence Update Recommendations

Work Group Project	PROJECT		
Prevention Work Group	Stigma and "Over the Counter Doesn't Mean On the Counter" Media Campaign Promotion Community Partner Expansion – Focused on Race Equity, ACEs, and Injury/Violence.		
Treatment Work Group	Harm reduction surveys to be distributed to increase HR materials and availability in the treatment setting.		
Harm Reduction/Rescue	Established Centralized Community Naloxone Distribution system, identifying sustainable, long-term funding for naloxone, Created sub-group focused on Good Samaritan law evaluation, and is helping implement the Harm Reduction Center law.		
Harm Reduction/Rescue with Statewide Conversation Group	Small Amount, a statewide fentanyl public awareness campaign.		
Recovery Work Group	Working with communities of color and faith-based communities to address overdose, leading to a working session with the Imani Breakthrough Project.		
Race Equity Work Group	Racial Equity Work Group to hold focus groups to help identify bias and discrimination & barriers to treatment. Also, working to fund a Race Equity Strategy Planning Process and a Law Enforcement/Community Conversation, and secure consultants and facilitators to help lead.		
First Responders	Work Group started meeting again in October with new leadership.		
Family Task Force	Reaching out to families impacted by fatal overdose to distribute family toolkits & condolence cards. Translating the condolence cards into Spanish, Working on next year's Family Toolkits, and promoting the Work Group's two pagers for families to post a remembrance.		
Substance-Exposed Newborn with Statewide Conversation Group	Planned and implemented Rhode Island's first-ever campaign to bring awareness to the supports available for pregnant people who use substances.
