# **Update from the Rhode Island Opioid Settlement Advisory Committee**

State Fiscal Year 2026 Allocation Percentages by Pillar/Priorities

Racial Equity	Ensuring racial equity across the continuum of care	3%	2%

Additional settlements came in last fiscal year totaling approximately \$11 million for the state. OMB included these in SFY25 as a placeholder - these were added to SYF2026.



# **Rhode Island's 2030 Goal: Reduce Overdose Deaths by 30%**


In 2023, fatal overdoses decreased by 7.3%, the first decrease in overdose deaths since 2019. Additionally, the rate of fatal overdose decreased by 11% among non-Hispanic, Black Rhode Islanders and 15% among Hispanic or Latino Rhode Islanders.

#### Total overdose deaths fell significantly below the 2023 projection, with 404 fatalities compared to 417.



## **Rhode Island's Performance Snapshot**




